PUBLIC NOTICE

On the basis of request of many companies and considering the status of quantity of Codeine Phosphate supplied by Government Opium and Alkaloid Factories (GOAF), Neemuch/Ghazipur against the Quota Allocations of this office for 2021 and the stock position of Codeine Phosphate at GOAF, Neemuch/Ghazipur, the lifting validity of Quota Allocations of Codeine Phosphate issued by this office in 2021 to procure from GOAF, Neemuch/Ghazipur was extended till 31.03.2022, as an one time relaxation vide this office Public Notice dated 24th December, 2021

2 Despite this very positive administrative measure, however many companies have requested for extending the lifting validity of Quota Allocation issued in 2021 to lift from GOAF, Neemuch/Ghazipur beyond 31.03.2022 due to shortage of Codeine Phosphate at GOAF, Neemuch/Ghazipur. Even the Chief Controller of Factories (CCF), New Delhi has requested for extension of validity as they could not import Codeine Phosphate of the F.Y. 2021-22, despite their best efforts, till date.

3 Considering these factors together and Codeine Phosphate being a Essential Narcotic Drugs (END) under NDPS Act, 1985, the lifting validity of Quota Allocations of Codeine Phosphate issued in 2021 to procure from GOAF, Neemuch/Ghazipur is hereby extended till 30th April, 2022.

4 All the firms who were allotted quota of Codeine Phosphate in 2021 to procure from GOAF, Neemuch/Ghazipur are invariably required to submit the details of quantity of Codeine Phosphate lifted in 2022 against the quota allocations of 2021 in the enclosed pro-forma in Annexure-A by **07th May, 2022**. In case of no quantity lifted in 2022, then a NIL report is required to be submitted within due date.

5 If any company, who were allotted quota of Codeine Phosphate in 2021, to be procured from GOAF, Neemuch/ Ghazipur fails to submit the requisite data, they may not be considered for further allocation in 2022.
