### Circular

Central Bureau of Narcotics, Ministry of Finance, Department of Revenue the authority for the purpose of effectively preventing and combating abuse of Narcotics Drugs and Psychotropic Substances and illicit trafficking, invites applications from eligible and willing candidates for the anticipated vacancy in the grade of Superintendent(Ex.) on deputation basis:

1.	Superintendent(Ex.)	Pay Scale Rs. 7500-250-12000
2.	Place of Posting	Guwahati
3.	Vacancy	One
4.	Eligibility	Officers in Customs & Central Excise Commissionerate – holding the posts of (i) Superintendent (Customs) or Superintendent (Central Excise)(Group B) OR (ii) Inspector of Central Excise with 3 years regular service in the grade.

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed 3 years.

The pay of the officers, who are selected on deputation will be regulated in accordance with the G.O.I. Department of Per.& Trg. O.M. No. 2/8/97-Estt(Pay II) dated 11.3.98 as amended from time to time. It is made clear to the willing candidates that the option once exercised will be the final and in the event of selection in Central Bureau of Narcotics, they will not be allowed to withdraw the same since it will seriously disrupt the process of filling up the vacancies. Selected candidates will have to make their own arrangement for residential accommodation. Ordinarily the deputation period will not exceed three years.
