Minutes of the Compassionate Appointment Committee-2022 held on 05.03.2022.

In compliance of the Hon'ble Central Administration Tribunal(CAT) Jabalpur Bench, Circuit Sitting, Indore order's dated 10.12.2021 in OA No.201/978/2021 to consider and decide the case of compassionate appointment of Shri Hemant Singh Shaktawat S/o Late Shri Surendra Singh Shaktawat, a committee of Compassionate appointment met on 18.01.2022 under the chairmanship of Shri Vikas Joshi, DNC, Kota. Shri Hemant Hingonia, DNC, Hqrs., Gwalior and Dr. Sanjay Kumar, DNC, Neemuch were the members of said Committee.

2. The said Committee considered the case of Shri Hemant Singh Shaktawat S/o Late Shri Surendra Singh Shaktawat and recommended that most of the staff is on field duty for the purpose of measurement and test measurement work therefore a request may be made with the Hon'ble CAT, Jabalpur Bench circuit sitting Indore to grant at least two months additional time to consider and decide the case of compassionate appointment of Shri Hemant Singh Shaktawat along other pending applicants.

3. Accordingly, this office filed a Misc. application before the Hon'ble CAT, Jabalpur Bench circuit sitting Indore for grant of at least two months. Our application is yet to be heard by the Hon'ble CAT.

4. Thereafter, another meeting of the Compassionate Appointment Committee was held on 08.02.2022, wherein, during the scrutiny of the documents, it was found that points allotted to candidates against the 100 point assessment scale were not proper and discrepancies were found between the figures available in the files and those noted down on the Part-C proforma.

5. Consequently, the Committee was of the view that each case file must be verified in detail and latest information pertaining to all the candidates for compassionate appointment should be secured prior to 17.02.2022. The next Committee meeting was scheduled for 18.02.2022 which was later moved to 05.03.2022. Meanwhile, all the applicants for compassionate appointment were asked to fill up fresh proformas giving the latest details of movable and immovable properties.

6. At the time of last committee meeting held on 08.02.2022, a total of 8 vacancies (1-UDC, 4-LDC, 2- Havaldar, 1-MTS) had been reported for compassionate appointment. Thereafter, Establishment section vide its office note dated 04.03.2022 has informed about 7 further vacancies for compassionate appointment against the grade of Havaldar for the year 2022. Consequently, following are the total vacancies available for compassionate appointment:

7. Against these 15 vacancies, a total number of 29 applications were received before the committee for compassionate appointment.

8. As per Board's letter F.No.A.12012/52/2018-Ad.III.B dated 15.05.2019, the scheme for compassionate appointment involves 100 point weightage system wherein each application is evaluated against 9 major matrices and points are given to the applicant based on the information so provided against each matrix.

9. At the time of scrutiny of applications, it was found that while No.4 matrix in the aforesaid letter proposes to give weightage points on the basis of value of the property, no applicant had included valuation details of the immovable property held by the family of the deceased government official. The committee was also of the view that it was very difficult to get timely and proper valuation details of each and every property held by the applicants. Earlier committee was also of the same view. Therefore, the committee decided to follow the following criteria of allocation of marks against Matrix No. 4:

10. Further, the committee also observed that against Matrix No. 3, which deals with annual income of earning members and income from property, some applicants have only mentioned manual labor as their occupation and have not provided the exact amount of income earned by them. In such cases, the committee has calculated their annual income as per legal minimum wages applicable for unskilled/ semi-skilled or skilled workers in their state of residence.

Thereafter, all the applications were checked and allocated marks as per the criteria given in aforesaid letter. The total marks received by each applicant is enclosed as Annexure-I. The applicants Smt. Ombala Devi and Ku. Renu Batham were earlier selected for Havaldar post but as both of them failed to clear the physical examination as per the Recruitment Rules in force, therefore will be considered for any post other than Havaldar, if eligible.

The cases of Sh. Ayush Bhargav and Sh. Gautam Nareda were not 12. considered by the committee as both are still Minors as on date and their cases will be considered afresh in the future sittings of the committee.

After allocation of marks, the candidates have been considered for each 13. of the vacancy starting from vacancy of UDC.

UDC Vacancy: There is 1 UDC vacancy for compassionate appointment 14. whose minimum education qualification is Graduate. The following applicants were considered for the said vacancy as per their marks in the 100 point matrix and education qualification:

Since Ku. Renu Batham has highest marks amongst the considered 15. candidate, consequently she is selected against 1 vacancy of UDC as per Annexure-A.

LDC Vacancy: Thereafter, the committee considered the appointment 16. against 4 vacancies of LDC. The minimum education qualification for LDC post is 12th. Consequently, the following candidates were considered by the committee for the post of LDC:

17. Out of the aforesaid candidates, the candidates from S.No.1 to 4 are recommended for the post of LDC as they have the highest score in 100 point matrix amongst the candidates considered by the committee. The list of recommended candidates for the post of LDC is enclosed as **Annexure-B**.

18. **Havaldar Vacancy**: Thereafter, the committee considered the appointment against 9 vacancies of Havaldar. The minimum education qualification for Havaldar post is 10th. Consequently, the following candidates were considered by the committee for the post of Havaldar:

19. Out of the aforesaid applicants, Sh. Shyamlal Vasunia is not eligible for appointment to the post of Havaldar on account of his education qualification. Consequently, remaining 9 candidates are selected for the post of Havaldar as per **Annexure-C**.

20. In addition to this, a reserve list of candidate for the post of Havaldar is also being selected, as per Annexure-C, which would be eligible for appointment to the post of Havaldar in case any candidate from the aforesaid list is unable to clear the physical examination or declines to join on the post of Havaldar.

21. **MTS Vacancy**: Thereafter, the committee considered the appointment against 1 vacancy of MTS. The minimum education qualification for MTS post is 10th. Consequently, the following candidate was considered by the committee for the post of MTS:

22. Since Smt. Ombala Devi has scored the highest marks in the 100 point matrix and has the necessary education qualification for MTS post, she is selected for the post of MTS as per **Annexure-D**.

23. The names of the selected candidates, recommended by this committee are enclosed as Annexure-A to D.

24. Age relaxation by the competent authority is required in case of some of the shortlisted candidates as per F.No.14014/02/2012-Estt. (D) para 6 (B) of OM dated 16.01.2013.

26. These recommendations may be placed before the Competent Authority for approval. However, before issuance of appointment letter, original documents of the aforesaid candidates may be called for and their genuineness may be verified and also other formalities like physical test/ standard in respect of candidates recommended for the post of Havaldar are completed.

27. All the remaining cases which could not make it to the select list for want of requisite marks in 100 point matrix will be considered afresh at the time of next Compassionate Appointment Committee meeting.

Meeting concluded its deliberations with a vote of thanks to the Chair.


