2. Their seniority will be reckoned on the basis of panel drawn by the above mentioned review DPC in the grade of Sub-Inspector (from LDC) for the years 2016-17 to 2021.

3. The official at S. no. 37 should note that:

(a) If he does not accept the offer of promotion within 10 days of issue of order and fail to report for duty at his respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of Sub- Inspector, for a period of one year.


(b) The promotion, in the higher grade, in respect of the official shall take effect from the date he takes over the charge of higher post.

(c) He is required to submit within one month of promotion, his option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27<sup>th</sup> July 2017. However, if he has been granted benefit of financial upgradation under the ACP/MACP Scheme, his pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

(d) He should note that his promotion is subject to the condition of successful completion of probation period of two years which can be extended, if his performance during the probation period is not found to be satisfactory.

4. His regular posting will be decided in due course. Till then he shall assume the charge of the promotional post on in situ (as is where is) basis.


