### Esstt. Order No. 11 /2024

As per the findings of the DPC for promotion to the grade of Inspector from the post of Sub-Inspector for the years 2024 held at the office of Narcotics Commissioner, Gwalior on 06.03.2024, the following official is hereby promoted in the grade of Inspector (Group 'B' Non-Gazetted), **on ad-hoc basis**, in Level-7 of pay matrix Rs. 44,900/- to 1,42,400/-, with effect from the date he assumes charge of the higher post.

2. The above official should note that:

(a) If he does not accept the offer of ad- hoc promotion within 10 days of issue of order and fail to report for duty at his respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of Inspector, for a period of one year.

(b) The officer is promoted on ad-hoc basis against his sealed cover vacancy. He will not claim any seniority and will be liable for reversion subject to outcome of the case pending against him.

(c) The ad-hoc promotion, in the higher grade, in respect of the officer shall take effect from the date he takes over the charge of higher post.

(d) He is required to submit within one month of ad-hoc promotion, his option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27<sup>th</sup> July 2017. However, if he has been granted benefit of financial upgradation under the ACP/MACP Scheme, his pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

4. His regular posting will be decided in due course. Till then he shall assume the charge of the promotional post on in situ (as is where is) basis.
