As per the findings of review DPC for the year 2001-02 (10.10.2001) to 2012-13 for promotion of Sub Inspector to the grade of Inspector held in the office of Narcotics Commissioner on 25.04.2023, the following Sub Inspector are hereby promoted to the grade of Inspector in their respective pay scale with effect from the date they assume charge of the higher post.

- 1. The officials should note that:
- (a) If they do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Inspector, for a period of one year.
- (b) Their seniority will be reckoned on the basis of panel drawn by DPC for the year 2001-02 (10.10.2001) to 2012-13 held on 25.04.2023.
- (c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.
- 2. The promotion, in the higher grade, in respect of the officials shall take effect from the date they take over the charge of higher post.
