- 2. The officers who do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Superintendent/DOO, for a period of one year.
- 3. Their seniority will be reckoned on the basis of panel drawn by the above mentioned DPC for year 2019 to 2023.



- 4. The Officers are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017.
