## Estt. Order No.26/2022

As per the findings of DPC for the year 2022 for promotion of Upper Division Clerk to the grade of Deputy Office Superintendent (DOS) held in the office of Narcotics Commissioner on 17-11-2022, the following Upper Division Clerks are hereby promoted to the grade of Deputy Office Superintendent in Level-6 of pay matrix Rs. 35,400 to 1,12,400/- with effect from the date they assume charge of the higher post.

- 1. The officials should note that:
- (a) If they do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Sub-Inspector, for a period of one year.

- 2. The promotion, in the higher grade, in respect of the officials shall take effect from the date they take over the charge of higher post.
