1. Shri Anil Kumar Sharma, Inspector should note that:
 - (a) This promotion order is subject to the outcome of the decision by the Hon'ble High Court of Delhi in the writ Petition (C) No.14763/2006 and Writ Petition No.21803/2006 in the High Court, Allahabad.
 - (b) If he do not accept the offer of Promotion within 10 days of issue of this order and fail to report for duty at the respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of District Opium Officer / Superintendent (Ex.), for a period of one year.
 - (c) His seniority in the grade of District Opium Officer/Superintendent (Ex.) shall be reckoned on the basis of the panel drawn by the DPC 2018.
 - (d) He is required to submit within one month of promotion, their option of fixation of pay on promotion as per DOP&T's O.M.No.13/02/2017-Estt.(Pay-I) 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DOP&T's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DOPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.
2. Shri Anil Kumar Sharma is also required to pass the departmental examination in terms of Departmental Examination (Central Excise and Customs) Rules, 2008, as amended.

3. The promotion, in the higher grade, in respect of Shri Anil Kumar Sharma, shall take effect from the date he take over the charge of higher post.
