As per the findings of the Original DPC for the year 2018 for promotion in the grade of Inspector from UDC/Steno and Sub-Inspector grade held in the office of Narcotics Commissioner on 09.10.2023, the following officials are hereby promoted in the grade of Inspector (Group 'B' Non-Gazetted) in Level-7 of pay matrix Rs. 44,900 to 1,42,400 with effect from the date they assume charge of the higher post.

1. The officials should note that:

(a) If they do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Inspector, for a period of one year.

(b) Their seniority will be reckoned on the basis of panel drawn by the above mentioned DPC for year 2018.

(c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. The promotion, in the higher grade, in respect of the officials shall take effect from the date they take over the charge of higher post.

3. They should note that their promotion is subject to the condition of successful completion of probation period of two years which can be extended, if their performance during the probation period is not found to be satisfactory.
