Estt. Order No.52/2014

Consequent upon finalisation of disciplinary case against Shri R.K.Rajak, Inspector, the findings of DPC for the year 2012-13 in respect of him, for promotion to the grade of Supdt./DOO which was kept in the sealed cover has been opened and he has been found 'FIT' for promotion. Accordingly, as per the findings of the said DPC 2012-2013 held on 28.08.2012, Shri R.K.Rajak, Inspector is hereby promoted to the grade of District Opium Officer / Superintendent (Ex.)(Group 'B'), in PB-2 [Rs. 9300-34800 + 4800 (Grade Pay)], notionally, with effect from the date of promotion of his immediate junior Shri Deepak Dubey.

1. The above official should note that:

(a) This promotion order is subject to the outcome of the decision by the Hon'ble High Court of Delhi in the writ Petition (C) No.14763/2006, Writ Petition No.21803/2006 in the High Court, Allahabad.

(b) If he does not accept the offer of Promotion within 10 days of issue of this order and fail to report for duty at their respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of District Opium Officer / Superintendent (Ex.), for a period of one year.

(c) His seniority in the grade of District Opium Officer / Superintendent (Ex.) shall be reckoned on the basis of the panel drawn by the DPC 2012-13 held on 28.8.2012.

(d) He is required to submit within one month of promotion, his option of fixation of pay on promotion under O.M. No. 7/1/80-Estt.I, dated 26.9.81. However, where the official has been granted benefit of financial upgradation under the ACP/MACP Scheme, his pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. The above official should also note that the above promotion is subject to the condition of successful completion of probation period of two years which can be extended, if his performance during the period of probation is not found to be satisfactory. The above officer is also required to pass the departmental examination in terms of Departmental Examination (Central Excise and Customs) Rules, 2008, as amended.
3. The promotion, in the higher grade, in respect of above official shall take effect from the date he takes over the charge of higher post at his respective place.
4. Consequent upon his promotion to the grade of Supdt./D.O.O., Shri R.K.Rajak is transferred from O/o DNC, Kota and posted to the office of Dy.Narcotics Commissioner, Neemuch with immediate effect. He may be relieved by the concerned authority and directed to join the new assignment immediately. A compliance report in this regard should be sent to the undersigned.
