## **Corrected RRs of MTS**

## MINISTRY OF FINANCE (Department of Revenue)

## NOTIFICATION

New Delhi, the 16th December, 2015

G.S.R. 976(E).—In exercise of the powers conferred by the proviso to Article 309 of the Constitution and in supersession of the Narcotics Department (Group "C" & "D" Posts) Recruitment Rules, 2002, in so far they relate to the posts of Daftry, Frash, Chowkidar and Safaiwala, except as respects things done or omitted to be done before the supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Multi Tasking Staff Group "C" posts in the Central Bureau of Narcotics under the Central Board of Excise and Customs, Department of Revenue in the Ministry of Finance, namely:—

- 1. Short title and commencement.—(i) These rules may be called the Ministry of Finance, Department of Revenue Central Bureau of Narcotics <u>Multi\*</u> Tasking Staff (Group 'C' posts,) Recruitment Rules, 2015.
  - (ii) They shall come into the force on the date of their publication in the Official Gazette.
- 2. Application:—These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.

- 3. Number of Post, Classification and Level in Pay Matrix\*:—The number of the said posts its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 4. Method of recruitment, age limit, qualifications etc:—The method of recruitment, age limits, qualifications and other matters relating to the said post shall be as specified in Columns (5) to (13) of the said schedule.
  - 5. **Disqualification.**—No person-
    - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. **Power to relax:**—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving:—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Bachward Classea, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
