1. The Dy. Narcotics Commissioner of each unit will further decide place of posting of the officers who have transferred to the field units. The history of postings of the officials may be given due consideration and postings may be given strictly according to the norms provided in the AGT Policy. Further, the rotation of officers who have completed 2yrs or more in a particular charge or have completed their tenure at a station should be rotated subject to tenure mentioned in the AGT guidelines.
2. Transfer of Officer at Sl. No. 1 has been made on their own request. The request letters of the officer (Sl. No. 1) is being sent to the DNC, Lucknow for deciding their eligibility for grant of TTA.
3. The posting station of officer at Sl. No. 3 will be further decided by the CCF, New Delhi.
4. The above officers should be relieved by 05.07.2019. All those officers who are not relieved by 05.07.2019 shall be deemed to be relieved in the afternoon of 08.07.2019 and their salary will not be drawn from the office where they are presently posted, after the said date. Before relieving they shall properly hand over the charge/ documents/ equipment/ items etc. A compliance report of relieving/ joining should be sent to the undersigned latest by 12.07.2019.
