Subject:- Annual General Transfer - 2024 - C/reg.

The AGT for the year 2024 is likely to be done during the month of Apr-May 2024. For this purpose, it has been decided to call for options for place of posting from all personnel who are due for transfer as per prevailing AGT Policy (available on website www.cbn.nic.in).

- 2. All personnel who have completed their tenure at their place of posting as per said transfer policy on the cut-off date i.e. 31.12.2023 may submit information in the enclosed proforma-I clearly indicating 5 preferences for a place of posting. Those personnel who have completed their tenure in the respective unit of posting and are due for transfer out of unit shall strictly provide their five options outside the present unit of posting. Similarly, those personnel who are due for rotation within unit on completion of 2 years shall provide their options only within the present unit of posting. Those personnel who prefer to be retained at their present place of posting shall be required to provide valid reasons along with evidence, if any for their retention. Further, it may be informed that in case of non submission of option by a person, it will be presumed that he/she is willing to be posted anywhere in CBN/CCF. The preference for place of posting once exercised will be final and will not be allowed to be withdrawn at a later date.
- 3. All representations received for transfer on compassionate grounds from personnel who are otherwise not due for transfer, may also be accompanied by duly filled up proforma I & III with your specific recommendations on the request made by the person. Those personnel requesting for transfer on medical grounds may be asked to provide documentary evidence in support of their ailments. Request for transfer from one unit to another unit will be entertained only at Hqrs. Level.

- 4. Perform-II may kindly be used to forward, in a consolidated manner, all the options/representations (in r/o personnel due for transfer) received from various personnel in field formations headed by you. All and representations from the personnel jurisdiction/charge may be sent to this office in a single bunch after duly segregating them grade wise/cadre wise with index of the representations attached. List of personnel who were on leave, training etc. in excess of 15 days in Class "C" Station, as mentioned in AGT Policy, if any, may also be sent to this office separately. The consolidated statement in the prescribed proforma-II may please be sent to this office. Performa-III may kindly be used to provide consolidated information separately in respect of personnel who have submitted representation for their transfer.
- 5. The complete information in respect of personnel working under your charge in all the cadres may please be sent to this office latest by 18.03.2024 so as to enable this office to consolidate the data within time limit. Any representations received after the said date shall not be entertained unless recommended by you on. It may be mentioned that the requests for transfer would be considered keeping in view the overall vacancy position and also subject to availability of substitutes where minimal staff strength is required to be maintained.
- 6. In view of the ensuing AGT, it is requested that no transfer/rotation orders be issued by the unit Dy. Narcotics Commissioner till the completion of AGT 2024 exercise at Hqrs. Level.
