The following Office Superintendents of Central Bureau of Narcotics are hereby promoted to the grade of Administrative Officer/Asstt. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. Their promotion, in the higher grade, in respect of above officials shall take effect from the date they take over the charge of higher post.
