CCF may carry out the rotation of Inspectors posted in the two factories and Delhi office, if so desired.

The officers should be relieved by 16.6.2017. All those officers who are not relieved by 16.6.2017 shall be deemed to be relieved in the afternoon of 23.6.2017 and their salary will not be drawn from the office where they are presently posted after the said date. Before relieving they shall properly hand over the charge/documents/equipment/items etc. A compliance report of relieving/joining should be sent to the undersigned latest by 30.06.2017.

The officials at S.No. 3, 8 & 11 will not be granted T.A/TTA. as they are transferred at their own request. They may submit their representation for cancellation of orders if they are not interested for transfer at their own cost, within a period of one week from the date of issue of this order.

This disposes off all the representations in the grade of Inspectors. No further representation will be entertained without joining at new station.

The Dy.Narcotics Commissioner of each unit will further decide place of posting of the transferred officials. The history of postings of the officials may be given due consideration and postings may be given strictly according to the norms provided in the AGT Policy. Further, the rotation of officers who have completed 2yrs or more in a particular charge should be rotated to another office as far as possible in the same station subject to tenure mentioned in the AGT guidelines.
