Application should be made in enclosed pro-forma along with requisite documents through post or e-mail (suptd-narco@cbn.nic.in) by 31st January, 2023. All the applications received from the existing companies by 31st January, 2023 will be processed for Provisional Quota Allocation followed by Main Quota Allocation as per their entitlement.

Application for Quota Allocation of Narcotics Drugs other than Medicinal Opium/ Codeine or for Exports and Government Supply purposes of any Narcotic Drugs: -The application for Quota Allocation of Narcotic Drugs other than Medicinal Opium/ Codeine or for Exports and Government Supply purposes of any Narcotic Drugs can be submitted at any time during the period from 1st January, 2023 to 10th November, 2023.
- 5. Application received after due date: No application, received after due date as mentioned above, shall be entertained.
- 6. Application for Additional Quota Allocation of Narcotics Drugs (Medicinal Opium/ **Codeine):** - For Additional Quota Allocation of Medicinal Opium/ Codeine, separate Public Notices shall be issued at the appropriate time.
